Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 18, 2023, placed the rating(s) of H R Ispat Private Limited (HRIPL) under the 'issuer non-cooperating' category as HRIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HRIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 03, 2024, August 13, 2024, August 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

It has its registered office and manufacturing facility located in West Bengal. Mr. Krishna Chandra Mondal having more than two decades of experience in the same line of industry, looks after the day to day operations of the company. He is supported by other directors Mrs. Shipra Mondal, Mr. Subha Deep Mondal and Miss. Poulami Mondal along with a team of experienced professionals.

Status of non-cooperation with previous CRA: Infomerics has continued the rating assigned to the bank facilities of HRIPL into ISSUER NOT COOPERATING category vide press release dated November 16, 2023 on account of its inability to carry out a review in the absence of requisite information from company.
