CARE Ratings Ltd. had, vide its press release dated August 24, 2023, placed the rating(s) of Kashibai Solar Energies (KSE) under the 'issuer non-cooperating' category as KSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 09, 2024, July 19, 2024, July 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Kashibai Solar Energies (KSE) was established in 2016 as a partnership concern at Mudhol, Karnataka by Mr. Kallappa Nyamagowda and Mr. Venkappa Nyamagouda. The company has set-up a 1 MW solar photovoltaic (PV) power plant located in Malali village, Bagalkot district of Karnataka. The project achieved commercial operational from February, 2017. KSE has an entered into long-term power purchase agreement with Hubli Electricity Supply Company Limited.
