### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 25, 2023, placed the rating(s) of Jnana Bandhu Education Trust (JBET) under the 'issuer non-cooperating' category as JBET had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JBET continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 10, 2024, July 20, 2024, July 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Trust

Jnana Bandhu Education Trust (JBET) was founded in 2011-12 by Mr M R Kumarswamy at a rural area between Pandavapura and Mandya in the state of Karnataka. The trust to start with took over Adhithya School from different trustees and also started Jnana Bandhu Vidhyalaya in the year 2011-12. In 2014-15, the trust started Jnana Bandhu Pre-University College in Pandavapura, Karnataka, which is recognized by the State Government of Karnataka.

**Status of non-cooperation with previous CRA:** Brickwork has continued the ratings assigned to the bank facilities of JBET to the 'issuer not-cooperating' category vide press release dated October 03, 2024 on account of its inability to carryout review in the absence of requisite information from the trust.
