Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 23, 2023, placed the rating(s) of Byrnihat Coal Private Limited (BCPL) under the 'issuer non-cooperating' category as BCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 08, 2024, July 18, 2024, July 28, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Assam based Byrnihat Coal Private Ltd (BCPL) was incorporated in March 2005 by Mrs. Babita Harlalka and Mr. Suresh Kumar Agarwala. After remaining dormant for about eight years, BCPL has started trading of different size of coal from August 2013. The company procures coal from local players and sells it to clients across Assam and Meghalaya.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of BCPL into ISSUER NOT COOPERATING category vide press release dated October 24, 2023 on account of its inability to carry out a review in the absence of requisite information from the company.
