## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 29, 2023, placed the rating(s) of Mahaprabhu Residency LLP (MRL) under the 'issuer non-cooperating' category as MRL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MRL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 14, 2024, July 24, 2024, August 03, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of MRL have been revised on account of non-availability of requisite information.

MRL was incorporated on April 25, 2019 by Mr Devansh Patel, Mr Jayprakash Patel and ten other partners to construct a residential real estate project 'Harmony Harikesh'. The MRLLP is a part of Ahmedabad-based 'Harmony & Times' group. The project; Harmony Harikesh is a residential project (registered under Gujarat Registration No. PR/GJ/AHMEDABAD/AHMEDABADCITY/AUDA/RAA09838/210222) consisting of three high-rise residential buildings of 30 floors aggregating 348 flats. MRLLP has launched the project in December 2021. The project is located at Science city road, Sola in Ahmedabad.
