Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 17, 2023, placed the rating(s) of Patidar Agricare (PA) under the 'issuer non-cooperating' category as PA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2024, September 11, 2024 and September 21, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

PA was established in 2015 by Mr. Dilip Patel and his family members. PA was set up to provide cold storage facilities at Dehgam (Gujarat). Earlier PA was engaged into both trading operations and cold storage facilities. FY18 onwards PA discontinued its trading operations and only focused on providing cold storage facilities on rent basis to customers.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PA into Issuer Not Cooperating category vide press release dated February 19, 2024 on account of its inability to carry out a review in the absence of requisite information.
