Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 04, 2023, placed the rating(s) of Sri Balaji and Company (SBC) under the 'issuer non-cooperating' category as SBC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 19, 2024, August 29, 2024, September 08, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Guntur based, Sri Pardhasaradhi and Company, was established in 1984 as a Partnership Firm and nomenclature changed to Sri Balaji and Company (SBC) in 1994. SBC was promoted by Mr. J. Sarangapani, Mr. J.Subba Rao , Mr. J.Pardhasaradhi and Mr. J.Venu Gopal. SBC is engaged in trading and manufacturing of cotton yarn with a total installed capacity of 2,040 tonnage p.a. at its manufacturing unit located at Guntur, Andhra Pradesh. The manufacturing process includes ginning of raw cotton into seeds and lint. The firm has major customers in Andhra Pradesh, Tamilnadu, Karnataka, Mumbai and Maharashtra. SBC purchases raw cotton mainly from local farmers and lint from dealers.
