Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 07, 2023, placed the rating(s) of Sree Varasidhi Vinayaka Cottons (SVVC) under the 'issuer non-cooperating' category as SVVC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVVC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 23, 2024, August 02, 2024, August 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sree Varasidhi Vinayaka Cottons (SVVC), was established in 2017 as a Partnership firm by Mrs. Y.Rajyalakshmi and Mrs.V.Revathi. The firm has a cotton ginning and pressing factory with a total installed capacity of 1, 51,200 Quintals p.a. at its manufacturing unit located at Jogulamba Gadwal District, Telangana State. The firm has major customers like Sri Lakshmi Saraswathi Textiles Arni Limited and Subbaraju Cotton Mill Private Limited among others. SVVC purchases raw cotton from farmers in and around Telangana state.
