Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 14, 2023, placed the rating(s) of Shiba Kali Agro Products Private Limited (SKAPPL) under the 'issuer non-cooperating' category as SKAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 29, 2024, June 08, 2024, June 18, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
