Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 12, 2023, placed the rating(s) of Nile Overseas (Nile) under the 'issuer non-cooperating' category as Nile Overseas had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. Nile Overseas continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2024, August 07, 2024 and August 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Panipat-based (Haryana) Nile Overseas (Nile) was established in 2014 as partnership firm by Mr Jasbir Singh and Mrs Jyoti Jaglan. Nile is engaged in manufacturing of mink blankets like double bed, single bed and baby blankets. Nile's manufacturing facility is located at Panipat (Haryana).

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of Nile into Issuer Not Cooperating category vide press release dated July 15, 2024 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of Nile into Issuer Not Cooperating category vide press release dated January 22, 2024 on account of its inability to carry out a review in the absence of requisite information
