#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated September 01, 2023, placed the rating(s) of Lotus Infrarealty Limited (LIL) under the 'issuer non-cooperating' category as LIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 17, 2024, July 27, 2024, August 06, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

#### About the company

Indore (Madhya Pradesh) based Lotus Infrarealty Limited (LIL) was incorporated as a closely held limited company in December 2010 by Chourasiya family. LIL is formed with a purpose to construct commercial and residential projects as well as construction and running of multiplex cinema under its own brand name. Currently, LIL has undertaken one residential project named "Shri Sai Lotus City" and one commercial project named "Lotus Convent Court". The company is also running multiplex 2 screen cinema at Satarpura.

**Status of non-cooperation with previous CRA:** Brickwork has continued the ratings assigned to the bank facilities of LIL to 'Issuer Not Cooperating' category vide press release dated March 18, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
