Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 13, 2023, placed the rating(s) of Chaitanya HI-Tech Engineering Company Private Limited (CHECPL) under the 'issuer non-cooperating' category as CHECPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CHECPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 29, 2024, August 08, 2024 and August 18, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.

Ramesh Kumar for setting up a manufacturing unit of camshafts. Over the years, the company has started production of other auto-parts apart from camshaft such as drive shaft, valve housing, plunger fitting, valve holders, armature shaft, rotor shaft, gear shaft, adjusting pin and lever shaft. The plants of the company are ISO TS 16949 certified.
