## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 18, 2023, placed the rating(s) of National Plastics (NP) under the 'issuer non-cooperating' category as NP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 03, 2024, July 13, 2024, July 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Ahmedabad-based (Gujarat) NP was established in1978 by Jayantilal Patel and his brothers. NPL is engaged into manufacturing of water and chemical tanks from sole manufacturing unit located at GIDC, Odhav Ahmedabad.

**Status of non-cooperation with previous CRA:** Acuite (SMERA) has continued the ratings assigned to the bank facilities of NP to 'Issuer Not Cooperating' category vide press release dated July 28, 2023 on account of its inability to carry out a review in the absence of the requisite information from the firm.
