Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 11, 2023, placed the rating(s) of Pranav Foundations Private Limited (PFPL) under the 'issuer non-cooperating' category as PFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 26, 2024, July 06, 2024, July 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Chennai-based PFPL, incorporated in June 1996, is a real estate development company primarily focused on small scale residential projects. The promoters have over two decades of real estate experience. The company also owns a four-floor banquet hall in a prime location of the city with a seating capacity of 1000 people per floor.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of PFPL to the 'issuer not-cooperating' category vide press release dated February 26, 2024 on account of its inability to carryout review in the absence of requisite information from the company.
