Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 17, 2023, placed the rating(s) of Avighna Dairy Products Private Limited (ADPPL) under the 'issuer non-cooperating' category as ADPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ADPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 02, 2024, July 12, 2024, July 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
