#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated October 11, 2023, placed the rating(s) of Copperstone Clothing Company (CCC) under the 'issuer non-cooperating' category as CCC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CCC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 26, 2024, September 05, 2024 and September 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
