Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 22, 2023, placed the rating(s) of Yogendra International (YI) under the 'issuer non-cooperating' category as YI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. YI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 07, 2024, August 17, 2024, August 27, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

West Bengal based Yogendra International (YI) established in the year 1988 was promoted by Mr. Bihari Lal Agarwala, Mr. Susil Kumar Mundra, Mr. Jogendra Kumar Khemka, Mr. Jay Prakash Jhunjhunwala, and Mr. Sanjay Jhunjhunwala. The firm has been engaged in manufacturing and exporting of hot dipped galvanized fence steel Items, perforated construction stakes, PVC Pipes, fittings and profiles, nuts & bolts. The manufacturing facility of the firm is located at industrial area, Hooghly, West Bengal with aggregate installed capacity of 20000 metric tons per annum.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of YI into ISSUER NOT COOPERATING category vide press release dated August 09, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
