Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 15, 2023, placed the rating(s) of Shiv Real Ispat Private Limited (SRIPL) under the 'issuer non-cooperating' category as SRIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 31, 2024, August 10, 2024, August 20, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SRIPL have been revised on account of non-availability of requisite information.
