Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 04, 2023, placed the rating(s) of KD Timber LLP (KTL) under the 'issuer non-cooperating' category as KTL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KTL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 20, 2024, July 30, 2024 and August 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Jaipur (Rajasthan) based KD Timber LLP (KTL) was formed in the year 2015 as a partnership concern by Mr. Dhruv Gupta and Mrs. Saroj Gupta. KTL is engaged in trading and processing of different types of timber logs, sawn timber and timber products. The plant of the firm is located in Gandhidham (Gujarat).

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KTL under Issuer Not Cooperating category vide press release dated March 08, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
