#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated August 07, 2023, placed the rating(s) of Mendine Pharmaceuticals Private Limited (MPPL) under the 'issuer non-cooperating' category as MPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 22, 2024, July 02, 2024, July 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Mendine Pharmaceuticals Private Limited (MPPL) was established as a proprietorship firm in the name of 'Mendine Pharmaceuticals' in the year 1937 by Dr. Probhat Chandra Chakraborty. Later in December 1975, it was converted into private limited company and the name of the company changed to the current one. Currently, the company is managed by Mr. Probhas Bondhu Chakraborty and Mrs. Kalpana Chakraborty. Since its inception, the company has been engaged in manufacturing of pharmaceutical products like carmozyme, amirid, catarex-at, growly etc. at its plant located at Maheshtala, Kolkata, West Bengal with installed capacity of 18,00,000 liters per year. The manufacturing facility of the company has ISO 9001: 2015 certification which enables wide acceptance of its products in the market.
