Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 04, 2023, placed the rating(s) of IRIS Health Services Limited (IHSL) under the 'issuer non-cooperating' category as IHSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IHSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 19, 2024, June 29, 2024, July 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in December 18, 2007, IRIS Health Services Ltd (IHSL) was promoted by Mr. Pavan Kumar Poddar, Mr. Govindswamy Sridharan, Mr. Nikhil Poddar, Mr. Ramesh Kumar Kedia, Mr. Vivek Kumar Kathotia and Mr. Sanjay Kumar Ginoria based out of Kolkata, West Bengal.
