Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 05, 2023, placed the rating(s) of R T Rice Industries (RTRI) under the 'issuer non-cooperating' category as RTRI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RTRI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 20, 2024, August 30, 2024, September 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

R T Rice Industries (RTRI) was set up as a proprietorship entity in January 2015 by Mr. Pramod Kumar Jain. The entity is into processing and milling of non-basmati rice. The entity has commenced operations from January 2015 onwards at its plant located at Raipur in Chhattisgarh. The plant has an installed capacity of 57600 metric ton per annum. Apart from own rice milling, the entity also does custom milling for Food Corporation of India, Government of Chhattisgarh. RTR procure paddy from farmers & local agents and sells its products through the wholesalers and distributors across Chhattisgarh.
