Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 26, 2023, placed the rating(s) of Gakhil Resort and Spa (GRS) under the 'issuer non-cooperating' category as GRS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GRS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2024, August 21, 2024, August 31, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Gakhil Resort and Spa (GRS) is a proprietorship entity established on April 2015 to initiate a hotel business and carrying on activities related to the hotel industry at Bojoghari, Gangtok in Sikkim.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of GRS into ISSUER NOT COOPERATING category vide press release dated August 14, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
