Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 11, 2023, placed the rating(s) of Ramesh Iron and Steel Company India Private Limited (RISCIPL) under the 'issuer non-cooperating' category as RISCIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RISCIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 27, 2024, August 06, 2024, August 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of RISCIPL have been revised on account of non-availability of requisite information.

The company originally started as a dealer in TMT bars, Cold Rolled, Hot Rolled Steel and currently is an exclusive dealer for SAIL & RINL with five branches at Coimbatore (2), Tirupur, Trichy and Cochin. The company has its headquarters at Coimbatore.

Status of non-cooperation with previous CRA: Infomerics has moved the ratings assigned to the bank facilities of RISCIPL to the 'issuer not-cooperating' category vide press release dated February 07, 2024 on account of its inability to carryout review in the absence of requisite information from the company.
