# **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated September 14, 2023, placed the rating(s) of Swastik Ginning and Pressing Industries (SGPI) under the 'issuer non-cooperating' category as SGPI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGPI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 30, 2024, August 09, 2024 and August 19, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

## About the company

Yavatmal (Maharashtra) based SGPI was established as a partnership concern in the year 2008. The entity is engaged in the business of cotton ginning and pressing at its manufacturing facility located at Yavatmal, Maharashtra.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SGPI under Issuer Not Cooperating category vide press release dated April 08, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
