### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 28, 2023, placed the rating(s) of Jarosniv Exports Private Limited (JEPL) under the 'issuer non-cooperating' category as JEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 13, 2024, July 23, 2024 and August 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Delhi based Jarosniv Exports Private Limited (JEPL), a government recognized Export House was incorporated on January 22, 1982 by Dr. Jagdish Joshi and Mr. Dhirendra Joshi. The company is currently being managed by Dr. Jagdish Joshi and Mr. Dev Alexander Joshi. JEPL is a manufacturer and exporter of leather garments and accessories such as jackets, pants, shirts, tops, bags, belts and other accessories. The manufacturing facility is located in Lawrence Road, Delhi.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of JEPL into 'Issuer not-cooperating' category vide press release dated August 27, 2024 on account of non-availability of requisite information from the company.
