Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 28, 2023, placed the rating(s) of Raipur Power And Steel Limited (RPSL) under the 'issuer non-cooperating' category as RPSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 12, 2024, June 22, 2024 and July 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in 2007, Raipur Power and Steel Limited (RPSL) is a closely held public limited company belonging to the Garg group of Ludhiana, Punjab. RPSL has its sole manufacturing facility located at Durg, Chhattisgarh, for manufacturing of sponge iron, ferro alloys (silicon manganese), billets, iron ore pellets, wire rods and hard black (HB) wires.

Status of non-cooperation with previous CRA: ICRA has continued the ratings assigned to the bank facilities of RPSL into 'Issuer not-cooperating' category vide press release dated September 13, 2024 on account of non-availability of requisite information from the company.
