Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 26, 2023, placed the rating(s) of DCR Distillery Private Limited (DDPL) under the 'issuer non-cooperating' category as DDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2024, August 21, 2024 and August 31, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Sagar-based (Madhya Pradesh) DCR Distillery Private Limited (DDPL) was incorporated in November, 2010 by Mr. Gajendra Singh Rathore along with his family members with an objective to set up a plant for manufacturing of Extra Neutral Alcohol (ENA) and Rectified Spirit (RS). The manufacturing unit of the firm is located in Mehar, Sagar - Madhya Pradesh.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of DDPL into Issuer Not Cooperating category vide press release dated May 08, 2024 on account of its inability to carry out a review in the absence of requisite information.
