Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 15, 2023, placed the rating(s) of Maa Bhagawati Re Rolling Mills Private Limited (MBRRMPL) under the 'issuer non-cooperating' category as MBRRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MBRRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 31, 2024, August 10, 2024, August 20, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of MBRRMPL have been revised on account of non-availability of requisite information.

About the company

Maa Bhagawati Re-Rolling Mills Pvt Ltd (MBRRMPL) was incorporated in November 11, 2009 by Mr. Rajesh Kumar Rajuka and Mr. Ajay Kumar Rajuka. The company has started its operation from July 2011 and the company has been engaged in manufacturing of various steel structures like steel rods, angels, flats, square etc. The manufacturing facility of the company is located at Sundergarh, Odisha with an installed capacity of 90,000 metric tons per annum (MTPA).

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of MBRRMPL into ISSUER NOT COOPERATING category vide press release dated March 14, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
