## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 01, 2023, placed the rating(s) of Alp Nonwoven Private Limited (ANPL) under the 'issuer non-cooperating' category as ANPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ANPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 17, 2024, July 27, 2024, August 06, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the company**

Modasa-based (Gujarat) ANPL was incorporated in 2012, by Mr Hareshkumar Dahyabhai Patel and is currently managed by Mr Mahendrakumar Hansarajbhai Patel and Mr Jagdish Ratilal Patel. The company is engaged into the manufacturing of nonwoven technical fabrics. ANPL operates from its sole manufacturing facility located in Modasa (Gujarat).

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of ANPL under Issuer Not Cooperating category vide press release dated August 14, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
