### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 14, 2023, placed the rating(s) of SKS Karkala Infra Projects Private Limited (SKIPPL) under the 'issuer non-cooperating' category as SKIPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKIPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 29, 2024, July 09, 2024, July 19, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
