## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated September 22, 2023, placed the rating(s) of Hariom Flexi Pack Industries (HFPI) under the 'issuer non-cooperating' category as HFPI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HFPI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 07, 2024, August 17, 2024 and August 27, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Since inception in 2010, HFI has been engaged in the business of manufacturing and printing of flexible packaging material. The product portfolio of the firm includes antifungal coated aper, laminated rolls, poly coated rolls and HDPE geo membrane sheet which is manufactured as per clients' demand and their specifications. The sole manufacturing facility of HFI is located at Kolhapur, Maharashtra.
