Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 29, 2023, placed the rating(s) of Wellcare Oil Tools Private Limited (WOTPL) under the 'issuer non-cooperating' category as WOTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. WOTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 14, 2024, July 24, 2024 and August 03, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Alwar, Rajasthan based Wellcare Oil Tools Private Limited was incorporated in 2010 (erstwhile Wellcome Oil Tools Private Limited. The company is currently being managed by Mr Surender Yadav and his nephews Mr Satish Yadav and Mr Ravinder Yadav. The company is engaged in the manufacturing oil field drilling equipment and has a product portfolio of around 250 equipment.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of WOTPL into 'Issuer not-cooperating' category vide press release dated January 31, 2024 on account of non-availability of requisite information from the company.
