Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 12, 2023, placed the rating(s) of Shri Balaji Oil Mills (SBOM) under the 'issuer non-cooperating' category as SBOM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBOM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2024, August 07, 2024 and August 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Furthermore, the firm also sells its by product i.e. mustard seed cake to cattle feed manufacturers located in Haryana. The firm is also engaged in trading of mustard seeds.
