Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 01, 2023, placed the rating(s) of Shanker Wood Private Limited (SWPL) under the 'issuer non-cooperating' category as SWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 17, 2024, July 27, 2024 and August 06, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Delhi based, Shanker Wood Private Limited (SWPL) was incorporated in December, 2010. It is currently managed by Mr Manish Goyal and Mr Robin Goyal with its registered office in Delhi and a branch office in Gandhidham. SWPL is engaged into trading of timber wood at its facility located in Delhi and Gandhidham.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SWPL into 'Issuer not-cooperating' category vide press release dated November 30, 2023 on account of non-availability of requisite information from the company.

BRICKWORK has continued the ratings assigned to the bank facilities of SWPL into 'Issuer not-cooperating' category vide press release dated October 20, 2023 on account of non-availability of requisite information from the company.
