Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 08, 2023, placed the rating(s) of Pankaj Steel Corporation (PSC) under the 'issuer non-cooperating' category as PSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 24, 2024, August 03, 2024 and August 13, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Pankaj Steel Corporation (PSC) was established in the year 1978 as proprietorship entity by Mrs. Usha Agarwal. The entity is into trading of iron and steel, mainly of alloy steel having application in heavy engineering. It also does processing jobs like heat treatment, bending, etc. or gets it done on job work basis as per customer requirements. The entity is also involved in demolition activities of PSU discarded assets; prior it was into ship breaking.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of PSC into Issuer Not Cooperating category vide press release dated May 21, 2024 on account of its inability to carry out a review in the absence of requisite information.
