### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 01, 2023, placed the rating(s) of R. K. Agarwal Agro Seeds Private Limited (RKAASPL) under the 'issuer non-cooperating' category as RKAASPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKAASPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 17, 2024, July 27, 2024 and August 06, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
