Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 24, 2023, placed the rating(s) of Sunlit Elements Private Limited (SEPL) under the 'issuer non-cooperating' category as SEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEPL continues to be non-cooperative despite repeated requests for submission of information through emails dated July 09, 2024, July 19, 2024, July 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
