## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 05, 2023, placed the rating(s) of Umachi Foods & Commodities Private Limited (UFCPL) under the 'issuer non-cooperating' category as UFCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UFCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 20, 2024, August 30, 2024 and September 09, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Umachi Foods & Commodities Private Limited (UFCPL) was incorporated in March-2014 by Mr. Jawahar Lal and Mrs. Rachana Luthra, while the operations of the company started in September-2014 (FY16 being the first full year of operations of the company). The company is engaged in the bulk trading of packaged basmati rice since the commencement of its operations. The company is primarily engaged in exports to the Middle East, Australia, Southeast Asia, etc. The basmati rice is procured from rice mills directly as well as through dealers and agents based in Delhi, Haryana, Punjab and Uttar Pradesh.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of UFCPL into Issuer Not Cooperating category vide press release dated November 22, 2023 on account of its inability to carry out a review in the absence of requisite information.
