#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated August 28, 2023, placed the rating(s) of H K Timbers Private Limited (HKTPL) under the 'issuer non-cooperating' category as HKTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HKTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 13, 2024, July 23, 2024, August 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

HKTPL is engaged into manufacturing of veneer sheets, manufacturing of plyboard, particle board and other plyboard products. H K Lumbers LLP Is the group entities of HTPL, which is engaged in same line of business saw milling and planning of wood.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of HKTPL into Issuer Not Cooperating category vide press release dated August 10, 2023 on account of its inability to carry out a review in the absence of the requisite information from the company.
