Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 31, 2023, placed the rating(s) of Avadh Cotton Industries_(Jamnagar) (ACI) under the 'issuer non-cooperating' category as ACI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 16, 2024, July 26, 2024, August 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Jamnagar (Gujarat) based ACI, a partnership firm, was constituted in January 2014. The key partners of the firm are Mr. Bharat Vaishnav, Mr. Rohit Sitapara, Mr.Parshotam Vaishnav, Mr.Rasik Vaishnav and Mr. Jaydeep Sapovadia. The firm is engaged in the cotton ginning and pressing of raw cotton.

Status of non-cooperation with previous CRA: ICRA has continued the ratings assigned to the bank facilities of ACI to 'Issuer Not Cooperating' category vide press release dated August 07, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
