Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 10, 2023, placed the rating(s) of G.Parandhamaiah And Company Cotton Ginning Mills (GCCGM) under the 'issuer non-cooperating' category as GCCGM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GCCGM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 25, 2024, September 04, 2024, September 14, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

G. Parandhamaiah and Company Cotton Ginning Mills (GCCGM) was established in 1973 as a partnership firm and promoted by Gorantla Punnaiah and his family members. The firm is engaged in manufacturing of cotton lint and seeds. The manufacturing unit is spread in total area 11 acres located at Ganapavaram, Guntur (Andhra Pradesh). GCCGM purchases raw cotton from farmers located in and around Guntur. The firm sells the cotton lint and seeds to the customers within Andhra Pradesh.

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of GCCGM to the 'issuer not-cooperating' category vide press release dated August 22, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
