Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 10, 2023, placed the rating(s) of Sungrace Syntex Private Limited (SSPL) under the 'issuer non-cooperating' category as SSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 25, 2024, October 05, 2024 and October 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Furthermore, the company does weaving activity on job work basis for others. Furthermore, the company is also engaged in the business of trading of grey and finished synthetics fabrics. The plant of SSPL is located at Bhilwara, Rajasthan which is a textile cluster.

Status of non-cooperation with previous CRA: BRICKWORK has continued the ratings assigned to the bank facilities of SSPL into 'Issuer not-cooperating' category vide press release dated May 08, 2024 on account of non-availability of requisite information from the company.
