### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated October 04, 2023, placed the rating(s) of Sri Sri Vigneswara Constructions (SSVC) under the 'issuer non-cooperating' category as SSVC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSVC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 19, 2024, August 29, 2024, September 08, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sri Sri Vigneswara Construction (SSVC) was established in the year 2004 as a partnership firm by Mr. V Ramanjaneya Reddy and his family members. The firm is engaged in execution of civil construction works and undertakes construction, excavation, roads, infrastructural works and other civil works projects awarded by the Public Works Department (PWD, Andhra Pradesh) and the firm assigns the same to sub-contractors. The firm is registered as a special class contractor from Irrigation & CAD (PW) Department, Government of Andhra Pradesh for execution of civil works. Currently, the firm executes for Public Works Department (PWD), Irrigation & CAD (PW) CPWD, Roads & buildings (R & B), Zilla Parishad, APSRTC, Municipal Corporation among others.
