### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 26, 2023, placed the rating(s) of Jugnu Foods Private Limited (JFPL) under the 'issuer non-cooperating' category as JFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2024, September 20, 2024 and September 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of JFPL have been revised on account of non – availability of requisite information.
