Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 03, 2023, placed the rating(s) of Rathi Hatcheries Private Limited (RHPL) under the 'issuer non-cooperating' category as RHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 18, 2024, September 28, 2024 and October 08, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Rathi Hatcheries Private Limited was incorporated in June, 2002 and is currently being managed by Mr. Ramesh Kumar, Mr. Krishan Kumar and Mr. Vinod Kumar collectively. RHPL is engaged in poultry farming business at its poultry farm located in Jind, Haryana.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of RHPL into Issuer Not Cooperating category vide press release dated October 21, 2024 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of RHPL into Issuer Not Cooperating category vide press release dated January 22, 2024 on account of its inability to carry out a review in the absence of requisite information.
