Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 19, 2023, placed the rating(s) of Shija Hospitals And Research Instituteprivate Limited (SHRIPL) under the 'issuer non-cooperating' category as SHRIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHRIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 03, 2024, September 13, 2024, September 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Shija Hospitals and Research Institute Private Limited (SHRIPL) (Erstwhile: Shija Clinic Private Ltd, name changed in 2001) was incorporated in December 1998 by Manipur based Dr Kh. Palin and Dr Kh. Bonney. Initially, Dr Kh. Palin was operating a clinic in Imphal since 1985 and gradually converted it to SHRIPL. Currently, SHRIPL is operating a 169 bed multi-specialty hospital at Imphal (West), Manipur, a 60 seat nursing training college under Shija Academy of Nursing and a 100 seat Shija Para-Medical Research Academy (SPRA, affiliated to Paramedical Council of India). SHRIPL is empanelled by various government and nongovernment authorities. The day-to-day operation of the hospital is being looked after by Dr Palin, along with support from other directors and experienced professionals.
