# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 20, 2023, placed the rating(s) of SCG Exports Private Limited (SEPL) under the 'issuer non-cooperating' category as SEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 05, 2024, August 15, 2024 and August 25, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SCG Exports Private Ltd (SEPL), promoted by the Gouti family commenced its operations in January 2007. SEPL started its operation by selling 'hand-made gold Jewellery' to Middle East markets where its entire hand-made jewellery is sold to SCG Jewellers LLC (SJL) and ALL Amirats Jeweller LLC (AAJL), (not related) based in Dubai, which in turn caters to countries in the Middle East. During FY14, SEPL forayed into Indian markets.
