## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 08, 2023, placed the rating(s) of Annapurna Cotex Private Limited (ACPL) under the 'issuer non-cooperating' category as ACPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 24, 2024, August 03, 2024, August 13, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of ACPL have been revised on account of non-availability of requisite information.

### **About the company**

Aurangabad (Maharashtra) based Annapurna Cotex Private Limited (ACPL) was incorporated in 2008 by the members of Goyal family. ACPL is engaged in cotton ginning and pressing activities and trading of cotton seeds. The company has 2 units located at Aurangabad (Maharashtra) and another in Telangana.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of ACPL to 'Issuer Not Cooperating' category vide press release dated October 10, 2023 on account of its inability to carry out a review in the absence of the requisite information from the company.

Brickwork has continued the ratings assigned to the bank facilities of ACPL to 'Issuer Not Cooperating' category vide press release dated October 03, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
