### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 12, 2023, placed the rating(s) of Shree Chhatrapati Sahakari Sakhar Karkhana Limited (SCSSKL) under the 'issuer non-cooperating' category as SCSSKL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCSSKL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2024, September 06, 2024 and September 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
